via shipped semen for the current breeding year.

1. Stallion fee is hereby agreed to be \$ \_\_\_\_\_, including a **non**-refundable booking fee of \$200.00. No semen will be shipped until all paid in full.

2. Mare is hereby certified to be breeding sound and free condition that would prevent conception.

Mare is currently: Maiden  Open  In Foal

3. Stallion fee must be paid **in full** prior to ordering first shipment. It is further agreed that the following charges will apply.

- a.) Stallion Collection- *First collection included in fee.* Each additional \$125.00
- b.) Shipping container (disposable) \$30.00, to be paid prior to ordering semen.
- c.) Actual shipping Fees per shipment.

4. You must contact ranch by **6:00pm Pacific Time** the evening prior to collection, to order semen. A fee of \$100.00 for "Same Day" collections or failure to order semen within the stated time frame.

5. You must have your mare checked for pregnancy at 18 days after insemination and mare must inoculated for equine rhinopneumonitis starting at 90 days gestation and every 60 days there after to ensure your live foal guarantee.

6. If the mare aborts or fails to produce a live foal, Mare Owner must contact BTC within 48 hours of discovering along with a veterinarian's report.

7. BTC will collect stallions Monday, Wednesday and Friday. Emergency collections are available on other days. Additional charges apply.

8. This contract contains a live foal guarantee. Alive foal is considered to be a newborn foal that stands, nurses and is alive for 3 days.

9. Mare Owner understands that BTC will not be liable for any infectious, transmittable, or inheritable diseases or conditions to the foal resulting from this breeding.

10. A Photostat copy, both sides, of the mare's registration paper must accompany the signed contract. **Owner recorded on the papers will be recorded on the stallion breeding report.**
